EDUCATION

In April 2023, NNSWCD partnered with Rappahannock, Friends of the Menokin Foundation, Belle Isle State Park, Tidewater Oyster Gardener Association, Department of Forestry, and Virginia Cooperative Extension to successfully host two separate "Thinking Outside The Sink" (T.O.T.S.) events for sixth graders from Richmond County Middle School and Montross Middle School. Lowery Becker, **Education & Conseration Specialist coordinated** with the schools and partners to ensure the students had a meaningful experience learning Northern Neck's watersheds. about the

Richmond County sixth graders T.O.T.S. event was held at the Bell Isle State Park. Students were broken into 5 groups and

rotated throughout the stations. These stations included seining for river aquatic organisms, how water flows through a watershed during storms, the life cycle and importance of oysters, wetlands and how to hike a trail, the role of a riparian buffer on water quality, and food webs.

Montross Middle sixth graders T.O.T.S. event was held at the Menokin Foundation. Students were broken into 4 smaller groups and rotated throughout the stations. These stations included kayaking, nature Bingo walk, the importance of water quality and the history of Menokin. For both events, each station was led by a different organization that provided different watershed experiences for the students.

OUTREACH

Household Hazardous & Electronic Waste (HHW)

There are seven total HHW's planned every year - three in the spring and four in the fall. Often we are asked "What is a household hazardous waste collection event?" or "what items are accepted?". A household hazardous & electronic waste (HHW & E-Waste) collection is an event where county residents and/or property owners are allowed to bring household hazardous or e-waste items to a designated location for proper disposal. Acceptable items can include pesticides, old paint cans, used oil, bad gas, fluorescent light bulbs, batteries, aerosol cans and so much more! E-waste items include TV's, computers, printers, phones, or any other electronic device. Northern Neck SWCD partners with the four localities, MXI Environmental Services, and Virginia Cooperative Extension (VCE) offices to make this event possible. PRODUCER CONFERENCE





NEW WEBSITE



The Northern Neck SWCD has two no-till drills available for rent. No-till farming has numerous benefits such as reduces soil & nutrient loss, increases organic matter, and improves water quality. This equipment is perfect for planting or reseeding pasture, hay land, field buffers, wildlife plots, and small acreage fields. We hope that by having these drills available to rent, the citizens of the Northern Neck are provided with an affordable means of incorporating conservation on their land so that we may all enjoy these natural resources for generations to come.



Our cost-share program is typically available for signup July through August.


