

# 2020 LETTER FROM THE CHAIR

Dear Partners in Conservation:

It is not unusual for agriculture and conservation to face unanticipated change and challenges. This year has confronted our Northern Neck producers and partners with challenges unlike those experienced in the past. The staff at NNSWCD has been remarkable in its ability to evaluate the change, adapt to the challenges, and still deliver the programs and services our community has come to expect.

Through the advocacy of our local conservation district, the Virginia Association of Conservation Districts, the Department of Conservation and Recreation, and the hard work of our legislators, we received the largest budget allocation for cost share in our history. These funds were used to put conservation practices on the ground by our motivated producers and landowners. These individuals care about water quality, erosion control, soil improvement, and a sustainable future for agriculture. Over 1.7 million dollars went to work for cover-crops, nutrient management, no-till methods, and engineered practices. These contributions help make the Northern Neck a special place and keep our agribusinesses viable. Additionally, we had several successful off-farm projects using reimbursement funds from the Virginia Conservation Assistance Program.

I am personally proud of our agricultural community here in the Northern Neck and the leadership provided by NNSWCD, NRCS, FSA, Virginia Cooperative Extension, and many others. All of these efforts have given us a rewarding year to look back on as we have protected the environment and worked to "feed the people."

# Safe Office Practices Keep District Work Flowing


Conservation work never stops. When COVID-19 shut the District Office's doors to the public last March, the staff was determined to maintain high standards of service, despite the pandemic. Working together to keep the office clean and safe, everyone agreed on a cleaning regimen, socially distant staff schedules, and other safety measures like having masks and gloves available.

Prior to the pandemic, the office was accessible to all during business hours. While planning the Virginia Ag BMP Cost Share sign up period, staff decided to implement an appointment only policy as a safety measure. Workstations in all common areas and meeting spaces received plexiglass shields. Partitions were installed in the technical office (see upper right). Adhesive markers on the floor remind everyone to stay six feet apart. A rental tent was put in the parking lot for shade and a place to wait while producers were screened before their appointments.

The Board of Directors and all committees did not meet from mid March until June, when Phase 3 relaxed some restrictions on gatherings. The Personnel Committee (see right) met at the District Office to conduct staff performance evaluations.

On June 24, 2020 the Board of Directors met after three months (see bottom right) at the Richmond County Public Meeting Room. Distanced seating, masks, and individually boxed lunches were just a few of the measures taken to ensure everyone's safety.

The District will continue to follow all CDC guidelines during this challenging time. The health and safety of our community, producers, directors, and staff are our primary concern. We look forward to serving you in FY 20/21.

# District Endows a Second College Scholarship for Conservation & Environmental Studies

The District now offers two one thousand dollar college scholarships to Northern Neck students majoring in natural resources, conservation, or environmental studies.

The J.C. Berger Conservation Advancement Scholarship is open to permanent residents of the Northern Neck entering their first year of study in one of the above mentioned fields. Mr. Berger, a long time District Director, is a champion of conservation education and youth programs.

The second scholarship, the James Edward Minor Ag Stewardship Award, is open to sophomores, juniors, and seniors majoring in the same conservation areas mentioned above. James Minor served as At-Large Director from 2003 until his untimely death in August 2019 and was deeply committed to engaging youth in agriculture. Resolutions officially naming the two awards were presented at the 2019 Holiday Dinner and Awards Presentation at Indian Creek Yacht and Country Club.

# 2020 J.C. Berger Conservation Advancement Scholarship

Austin's interest in water quality and conservation is a product of growing up on the Northern Neck and its waterways. This fall he began his first year at Eastern Mennonite University, where he studies business and turf management. Austin Hopes to own a landscaping business in the future and looks forward to helping property owners understand the negative impact of overfertilization and pesticide usage close to waterways.

# **COVID Stops District's In-Person Conservation Education for Northern Neck Students**

In the fall of 2019, our *A River Runs Through Us (ARRTU)* program kicked off a successful semester of conservation education for Northern Neck students. Roughly 300 sixth graders from the counties of Richmond, Lancaster, Northumberland, and Westmoreland explored "the world beneath your feet" going "underground" to see examples of the millions of organisms that don't only rely on soil but in many cases, enrich it too.

ARRTU is one of several environmental conservation lessons that are a part of a Meaningful Watershed Education Experience (MWEE) that the District conducts with local partners. As part of the MWEE, lessons come together at *Think Outside the Sink (TOTS)*, an interactive field experience that normally takes place every



spring. Unfortunately, those students we met in in the fall were never able to experience the spring field experience due to COVID.

In February 2020, a classroom visit to Richmond County 4th graders was the only in-person lesson that took place. That lesson introduced students to watersheds with an interactive exercise from Project WET, Sum of the Parts. In the above photo, students design the layout of their own piece of waterfront property. The pieces are put together to form a river. As each student introduces their property, there is a discussion of the impact that each piece of property, whether it is a dairy farm, a golf course, or a private home, has on the body of water that flows past it and where all of the pollution ends up.

We are excited to work with local teachers and develop virtual lessons to assist them any way possible. We look forward to returning to classrooms in person, which we hope will be sooner rather than later.

# **District Welcomes Four New Directors**

The NNSWCD Board of Directors introduces its four new members who took office at the beginning of 2020. There were three vacant seats for voters to fill during the November 2019 election. Lancaster County voters chose two new representatives, Faye A. Andrashko, a long-time educator and conservation advocate, and William "Billy" McCarty, III, Shellfish Specialist with the Virginia Department of Health and part-time farmer. Westmoreland County's newly elected District Director is Richard Wilkins, owner and operator of Cedar Hill Farm in Colonial Beach.

The At-Large Director position, an appointed seat on the Board, was left vacant by the sudden death of James Edward Minor in August 2019. Following a review of potential appointees, NNSWCD's Board voted at the February meeting to appoint Louis Gregory "Greg" Basye of Lottsburg, VA to the At-Large Director seat.


