**Dear Partners in Conservation:** 



The NNSWCD administers the Virginia Agricultural Cost-Share (VACS) Program, which provides funds and/or state tax credits for the installation of conservation practices that prevent soil erosion and runoff that pollute our streams, rivers, and the Bay. VACS offers different practices that assist farm landowners and producers in maintaining soil on the land, with consequent benefits to crop production and water quality. The implementation of conservation practices also assists localities in working toward the nutrient and sediment reduction goals outlined in the State's Chesapeake Bay TMDL Watershed Implementation Plan (WIP III).

This table illustrates the practices installed in each county of the Northern Neck, and the amount of funds reimbursed to producers for BMP implementation during FY 20/21 through VACS.

# **VIRGINIA CONSERVATION ASSISTANCE PROGRAM (VCAP)**

The Virginia Conservation Assistance Program (VCAP) is an urban cost-share program that provides financial incentives and technical and educational assistance to property owners installing eligible Best Management Practices (BMPs) in Virginia's participating Soil and Water Conservation Districts (SWCDs).

These practices can be installed in areas of your yard where problems like erosion, poor drainage, or poor vegetation occur. Living Shoreline practices are especially practical in the Northern Neck.

In FY 20/21 the NNSWCD received 55 VCAP applications. See below for details on approved and completed projects as of June 30, 2021.

# HOUSEHOLD HAZARDOUS WASTE/E-WASTE PROGRAM

The NNSWCD held five Household Hazardous Waste (HHW) collections in FY 20/21. Because Northern Neck residents dropped off nearly 90,000 lbs. of HHW and 34,000 lbs. of electronic waste (E-Waste), we can ascertain that these items were recycled or disposed of properly, no longer a danger to our natural resources.

Each county saw record attendance at the socially distanced events. Participants were asked to remain in their vehicles while masked crew members unloaded their items.

# JOHN C. BARBER JANUARY 6, 1925 – FEBRUARY 6, 2021

Dr. John Clark Barber was a friend to conservation efforts in the Northern Neck. Following a career with the U.S. Forest Service, he belonged to several conservation organizations. Dr. Barber served the NNSWCD for 30 years, as an elected District Director (1998-2000) and as an Associate Director (1991-1997 and 2001-2021).

## SAVANNAH HARRIS NAMED 2021 J.C. BERGER SCHOLARSHIP RECIPIENT

Savannah Harris, daughter of Keith and Kathryn Harris of Heathsville was the 2021 recipient of the \$1,000 J.C. Berger Conservation Advancement Scholarship. Savannah, a 2021 graduate of Northumberland High School, successfully balanced a demanding class load, her role as Senior Class President, and her membership in Beta Club, graduating with a 4.19 GPA. In addition, Savannah competed on the Dance Team for the past four years and played field hockey for two years. In 12 years of school, she appeared on the Honor Roll consistently.

Savannah credits growing up on her family's farm for her awareness of the importance of responsible stewardship of natural resources. She begins her studies at Virginia Tech this fall, where she will major in Environmental Science. Savannah plans to become a marine biologist and work in the conservation field. One of her main concerns is the growing problem of pollution in local waterways and in the world's oceans. Ultimately, she hopes to return to the Northern Neck and help those in the farming and fishing industries use more eco-friendly methods in their work.



## **COVID-19 AND CONSERVATION**

## FLEXIBILITY, CREATIVITY ESSENTIAL TOOLS WHEN WORKING THROUGH A PANDEMIC

By the end of FY 20/21, 16 months had passed since the NNSWCD locked its doors to the public as a result of the COVID-19 pandemic. This past year has yielded many *lessons learned* as the District has continued to conduct "business as usual" when it has been anything but "usual".

The nature of our work depends on interaction with others. Whether it is conducting our 6th grade watershed lessons, doing field work for VCAP and VACS or sitting down with our producers at cost-share sign-up time, face to face communication has always been the way that the NNSWCD serves the people of the Northern Neck. During certain times of the year, the District Office has many visitors such as producers signing up for programs or picking up cost-share checks. Of course, these interactions had to move outdoors, with staff members and members of the public wearing masks and practicing social distancing. Cost-share sign ups moved to a tent in the parking lot, on an appointment only basis, with screening procedures and a log to record each person's visit.

Household Hazardous Waste collections took place as socially distanced events to ensure the public's safety. Participants experienced a new level of service as they were asked to remain in their vehicles and to allow the event staff to unload their chemicals and electronics. Record numbers of HHW were collected at several events, with many participants saying that staying at home during the pandemic gave them plenty of time to clean out basements and garages.

The NNSWCD partners with all Northern Neck counties on classroom lessons for 6th grade science students. During FY 20/21 staff members collaborated with teachers to present lessons virtually, allowing students to participate whether they were in the classroom or at home. It was a challenge to not have in person sessions using the Mobile Education Unit, but technology allowed for some creativity while presenting lessons on Watersheds and Solutions, which was delivered three times during the year. Watersheds, Oysters, and Solutions was a special unit requested by Northumberland County, which was delivered twice. All lessons were delivered in real time over a virtual platform using discussion, videos, and visual aids.

Over the past 16 months the NNSWCD has grown in the knowledge that it is possible to detour from normal routines with successful results. While times remain uncertain, the NNSWCD will continue our mission while following CDC guidance and state laws to ensure the safety of the public, District staff members and directors.
